**Please Note the Following Instructions:**

1. Only stallions subscribed to the Breeders' Trust for the 2009 breeding year are eligible for the Platinum Division.
2. All mares exposed must be listed on the stallion's Stallion Breeding Report (SBR) for the year in question.
3. Stallion owner/lessee must pay \$100 nomination fee per mare listed on the SBR. Late fees will apply to any mare that is added after the SBR deadline. Failure to pay for all mares exposed could result in disciplinary action.
4. Platinum enrollment will not be accepted if all current year SBR fees are not paid-in-full.
5. All **Regular Registry** foals sired by Platinum stallions will be eligible to participate in the Platinum division of the Breeders' Futurity.
6. Platinum enrollment at regular fees must be received in the office or postmarked by November 30 of breeding year.

**Fees & deadlines:**

November 30 of breeding year:  
\$100 per mare on SBR.

If filing late SBR:  
\$500 plus \$100 per mare bred.

If adding mare(s) to any SBR:  
\$250 (one time) plus \$100 per mare added.
