**Please Note the Following Instructions:**

1. The stallion subscription must be made in the exact name of the stallion's owner or the lessee on record with APHA. If someone other than the recorded owner or lessee wishes to subscribe the stallion, then a waiver must be signed by owner or lessee.
2. The stallion subscription fee is the highest advertised breeding fee for the season (color guarantees, chute fees and booking fees must be included in determining highest advertised breeding fee), with a minimum of \$400 and a maximum of \$3,000. The fee for stallions standing at "private treaty" or "does not stand to public" is a minimum of \$700 or the actual private treaty fee, whichever is higher. Subscription payment is due at the time of nomination, and should accompany this form.
3. Stallion subscriptions at regular fees must be received in the office or postmarked on or before January 31 of the breeding year. Stallions standing for the first time have until March 31 of the breeding year to be subscribed without a late penalty. (Postal meter dates will not be accepted.) Late subscriptions will be accepted throughout the breeding year at the following rates:

January 31 of breeding year	Highest stud fee
February 1 to March 31 of breeding year	One and one-half advertised fee
April 1 to December 31 of breeding year	Double the advertised fee

**No subscriptions will be accepted after December 31 of the year bred.**
